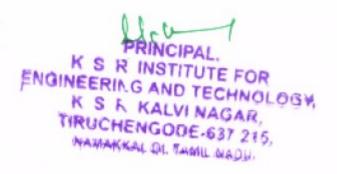
Report on I Year Students Induction Programme 2021 Universal Human Values

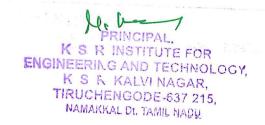
